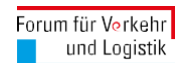

Contact person

Please appoint a contact person (name and mobile number), who is responsible for the stand during the event (including assembly and dismantling).

Registration fee for the staff at the stand

The organiser does not distinguish between participants of the conference and staff at the stand. Therefore, all company representatives have to be registered as participants of the conference. The 1st and 2nd registered person pay the full participation fee. As from the 3rd person registered the registration fee is Euro 450.00.

Cancellation of the conference/exhibition

If it is not possible to hold the conference/exhibition due to force majeure or for another important reason (e.g. too few participants), the participants will be informed immediately via the contact data they have noted in their registration. In this case already paid participation fees will be refunded. It is not possible to make further claims against the organiser.

Liability

The organiser is only liable for any damage occurring due to the realisation of the conference in case of wrongful intent and gross negligence. The limitation of liability does not apply to damage to life, body or health caused by culpable neglect of duty on the part of the organiser, its legal representatives, its agent or its subcontractors. Furthermore, the limitation of liability does not apply to damage caused by culpable neglect of a so-called major obligation (in German "Kardinalpflicht"), which is a contractual obligation the fulfilment of which is deemed to be necessary for due and careful completion of the contract and may with good reason be permanently relied on by the exhibitors.
